I write in connection with your request for information received by the Norfolk Constabulary on the 12th January 2016 in which you sought access to the following information:

Since November 2015 how many times have either the Police or the Safety Camera partnership conducted speed assessments on Sir Alfred Munnings Road. For each time, how many vehicles were checked and how many were deemed to be speeding? If possible can you please put that as a percentage as well. If there is a break down of speeds I would appreciate that as well, but this information is not necessary if it will cost you too much

Norfolk Constabulary holds information relevant to your request.

Response to your Request

In order to establish what information may be held regarding your request, we have contacted both the Safety Camera Partnership Team and the Inspector of the South Norfolk District Command.

I can now advise that since November 2015, speed checks have been carried out on Sir Alfred Munnings Road on the following dates:

12th November 2015
20th November 2015
3rd December 2015
7th December 2015
16th December 2015
8th January 2016
11th January 2016

Information relating to the number of vehicles checked on the above dates is not recorded, therefore no information is held with regards to this part of your request.
