Freedom of Information Request Reference N°: FOI 002127/20

I write in connection with your request for information received by the Norfolk and Suffolk Constabularies on the 22nd June 2020 in which you sought access to the following information:

- A the number of officers assigned to specialist roles supporting domestic abuse/violence victims in each of the last five years
- B the number of arrests made for domestic abuse/violence in every month so far this year (2020)
- C the number of arrests made for domestic abuse/violence in each of the last five years
- D the budget in each of the last five years for any specialist domestic abuse/violence unit that the force may have
- E the amount spent on training police officers in supporting domestic abuse/violence victims in each of the last five years.

Response to your Request

The response provided below is correct as of 16th July 2020.

Norfolk and Suffolk Constabularies have considered your request and our response is below.

- A All officers across the Constabularies will be involved in investigating domestic related crimes. We have provided below the number of officers (excluding police staff) who work in the Safeguarding department, whose roles will include domestic offences.

Norfolk Safeguarding is aligned with the Investigations Department, therefore, whilst we have provided the number of officers in the dedicated Safeguarding unit, the crimes are often investigated by the Investigations Unit.

With regard to Suffolk, units within the Crime, Safeguarding & Incident Management Command include the Internet Child Abuse Investigations Team, Safeguarding Hub and Safeguarding Units.

Similarly to Norfolk, Suffolk Safeguarding teams work alongside Investigations Departments in order to investigate crimes effectively.
