**Response to your Request**

Norfolk Constabulary has located the following information as relevant to your request.

The first 4 tables have been extracted from the Constabulary's crime system which was in use up to 20<sup>th</sup> October 2015. From this date a new crime recording system, Athena, was introduced. The final two tables relate to this new recording system.
