I write in connection with your request for information received by Norfolk Constabulary on the 2nd July 2020 in which you sought access to the following information:

Please furnish me with full information under the Freedom of Information Act 2000 provision for the period since 31st December 2019, relating to calls details made concerning Anti-Social Behaviour in and, within immediate proximity to, the Haymarket in Norwich.

Full individual call detail to include (but not restrictively);

- A The date and time of the call
- B The nature of the alleged ASB
- C Pseudonymised caller information (so that repeat callers can be analysed).
- D Pseudonymised subject information (so that repeat subjects can be analysed).
- E Outcome to the call (non-attended, attended etc.)
- F Outcome to the alleged offence, none, warned, cautioned, arrested, ASB order issued, other punishment etc.)
- G Supplementary information to translate abbreviations, acronyms and codes etc.
